#### **Organizational Setting**

The Food and Agriculture Organization of the United Nations (FAO) contributes to the achievement of the 2030 Agenda through the FAO Strategic Framework by supporting the transformation to MORE efficient, inclusive, resilient and sustainable agrifood systems, for *better production*, *better nutrition*, a *better environment*, and a *better life*, leaving no one behind.

The FAO Financing for Shock-Driven Food Crises (FSFC) is led by the Chief Economist and is promoted by the Government of Italy in the context of G7 under the Italian Presidency in 2024. The facility will be the first opportunity to scale up a new approach for the humanitarian community to self-insure donor resources and increase the funding available to mitigate the impact of extreme shocks that drive high levels of acute food insecurity.

The post is located in the Office of the Chief Economist at FAO headquarters, Rome, Italy.

#### **Reporting Lines**

The Junior Professional Officer reports to the FAO Chief Economist.

#### **Technical Focus**

Provide overall technical, analytical, coordination support and advice for FSFC and other key priorities of the Strategic Framework related to the stream of the Chief Economist and issues related to food security, nutrition and agrifood systems transformation.

- Contributes to the modeling and analysis including country risk analysis.
- Assists the team in building a diversified portfolio of risks, as well as identification of market-ready instance products and triggers.
- Contributes to the preparation of various written outputs, e.g. draft background papers, analytical notes and presentations.
- Assists in the preparation, organization and reporting of meetings, including the preparation of working documents, ensuring a high level of consistency and accuracy.
